GENERAL RELEASE AGREEMENT

ALL PARTICIPANTS IN THE TENNESSEE RIVER RUN EVENT AND RELATED EVENTS ARE REQUIRED TO ASSUME ALL RISK OF PARTICIPATION BY SIGNING THIS GENERAL RELEASE AGREEMENT

The undersigned participant (individual) on behalf of himself/herself and on behalf of Individual's personal representatives, assigns, heirs, executors, hereby fully and forever releases, waives, discharges and covenants not to sue the City of Savannah, the Darryl Worley Foundation, all public or private agencies whose property and/or personnel are used and all other sponsoring or co-sponsoring companies or individuals, including volunteers, related to the City of Savannah and Darryl Worley Foundation (collectively releases) from all liability of any kind to the individual and his/her personal representatives, assigns, heirs and executors, for all loss(es) or damage(s) and any and all claims, demands, losses or damages on account of injury or death to the Individual or their respective property or resulting in the death of the Individual, whether caused by the active or passive negligence of all or any of the releases or otherwise, in connection with the Individual's participation in the Event.

The Individual is fully aware of the risks and hazards inherent in participating in the Tennessee River Run Event(s) and elects to voluntarily be involved in said event, knowing the risks associated with the Tennessee River Run Event. The Individual hereby assumes all risks of loss, damage, or injury that may be sustained by him/her while participating in the Event(s).

The Individual agrees to the use of his/her name and photograph in broadcasts, newspapers, brochures and other media without compensation.

The Individual hereby grants to the City of Savannah, the Darryl Worley Foundation and their agents, affiliates and designees access to all medical records (and physicians) as needed and authorizes medical treatment as needed.

The Individual warrants that all statements made herein are true and correct and understands that this release agreement is relative to them in allowing Individual to participate in the Event(s).

Individual further agrees to hold harmless and indemnify said City of Savannah and the Darryl Worley Foundation, their directors, employees and agents from any liability sustained by said organization as the result of the negligence, willful or intentional acts of said Individual.
